



# Sun Safety

## 2022 Poster Contest

**PURPOSE:** The Pennsylvania Academy of Dermatology and Dermatologic Surgery (PAD) and American Society for Dermatologic Surgery Association (ASDSA) are comprised of board-certified dermatologists who are experts in skin care and sun safety.

In 2017-2018, the PAD worked with Pennsylvania lawmakers to pass a law that allows students to bring sunscreen to school without needing a letter from a physician and without having to store it in the nurse’s office. We believe this law was crucial to help students protect themselves from ultraviolet (UV) light. The goal of the Sun Safety Poster Contest is to educate K-12 students and their teachers about the recent law and the importance of UV protection.

**RESOURCES FOR THE CONTEST:** The PAD and ASDSA believe that a significant way to impact student health is to help fund educational programs at school and encourage follow through at home. A group of leaders from the PAD will evaluate each submission presented to ensure that it addresses all of the requirements noted below. # 2022 Contest Timeline

**February 28<sup>th</sup>, 2023:** Applications due  
**March 17<sup>th</sup>, 2023:** Winner notified, and grant distributed  
shortly thereafter  
**December 17<sup>th</sup>, 2023:** Grant outcome description due

## CONTEST GUIDELINES:

1. The artwork must be original and created by a student in grades K-12.
2. Artwork must be submitted on 11"x14" or smaller paper or cardstock to the school's media specialist, or other designated school personnel. Please write the student's name, grade, and school name on the back of the project. Include application form and plan for use of the grant money with the submitted artwork.
3. Each school should select one (1) winner to represent their school in the statewide contest. Multiple schools in a district may submit an entry, but only one entry per school will be accepted.
4. Artwork should exemplify sun safety behavior, sunscreen use, and/or the recent sunscreen in schools' law. The artwork should target a school-age audience and educate them in some way on how to protect their skin from UV damage. Artwork can have pictures only, words only, or both.
5. Artwork must be sponsored by a teacher or school administrator who is listed on the application.
6. The artwork submission must include a plan for use of the \$5,000 award. In past years the PTO has been a partner with the school to help implement the project, we advise you coordinate with your PTO (or equivalent) to complete the application and include a letter indicating their support.
7. Grant money must directly benefit students at the submitting student's school. Special consideration may be given to those submissions whose plan involves a project or tools to improve the health or safety of students. This plan must be approved and cosigned by the school principal.
8. The grant will be issued in the form of a \$5,000 check to the school and \$50 gift card to the student.
9. Prize recipient sponsor must submit a short post-project summary of how funds were used. Deadline for this summary is December 17<sup>th</sup>, 2023.
10. Winners of the contest give permission for the PAD and ASDSA to use their poster on their websites, in presentations, and/or in other educational materials.
